TRUSTEES' REPORT

FOR THE YEAR ENDED 31 AUGUST 2023

The trustees present their annual report together with the accounts and auditor's report of the charitable company for the year 1 September 2022 to 31 August 2023. The annual report serves the purposes of both a trustees' report, and a directors' report and strategic report under company law.

The academy trust operates an academy for pupils aged 5 to 19 serving a catchment area in Northamptonshire. It had a pupil capacity of 114 and had a roll of 114 in the school census in October 2022.

Structure, governance and management

Constitution

The academy trust is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the academy trust.

The trustees of Maplefields Academy are also the directors of the charitable company for the purposes of company law. Details of the trustees who served during the year, and to the date these accounts are approved, are included in the Reference and Administrative Details on page 1.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

Trustees' indemnities

In accordance with normal commercial practice the academy has purchased professional indemnity insurance to protect trustees from claims arising from negligent acts, errors or omissions occurring whilst on academy business.

Method of recruitment and appointment or election of trustees

The members of the Academy Trust may appoint up to six trustees. The members may appoint staff trustees, so long as staff trustees do not exceed one third of the board of trustees. The local authority may appoint one trustee. Parent trustees are elected by parents of registered pupils at the academy. The head teacher is treated as an ex officio trustee. The Secretary of State may appoint additional trustees under special circumstances. The articles of association require no less than three trustees.

The term of office for any trustee shall be 4 years except the head teacher who remains a trustee whilst in post. Trustees are eligible for re-election at the meeting at which they retire.

Policies and procedures adopted for the induction and training of trustees

The training and induction provided for new trustees will depend on their existing experience. Where necessary induction will provide training on charity and education legal and financial matters. All new trustees will be given a tour of the academy and the chance to meet with staff and students. All trustees are provided with copies of policies, procedures, minutes, accounts, budgets, plans and other documents that they will need to undertake their role as trustees. As there are normally only one or two new trustees a year, induction tends to be done informally and is tailored specifically to the individual.

Organisational structure

The management structure consists of four levels; the Members, the Trustees, the Senior Managers and the Management Team. The aim of the management structure is to devolve responsibility and encourage involvement in decision making at all levels.

The original Members were signatories to the articles of association which includes definition of the trusts' charitable object and governance structure, they have power to appoint Trustees as set out in the trust's articles of association, and have power under the Companies Act to remove any or all serving Trustees.

The Trustees are responsible for setting general policy, adopting an annual plan and budget, monitoring the academy by the use of budgets and making major decisions about the direction of the Academy, capital expenditure and senior staff appointments.

The Senior Managers are the Head teacher, Deputy Heads, and the Finance Manager. These managers control the academy at an executive level implementing the policies laid down by the Trustees and reporting back to them. As a group, the Senior Managers are responsible for the authorisation of spending within agreed budgets and the appointment of staff, although appointment boards for posts in the Management Team always contain a Trustee. Some spending control is devolved to members of the Management Team, with limits above which a Senior Manager must countersign.

The Management Team includes the Senior Management, the Phase Leaders and the Curriculum Area Managers. These managers are responsible for the day to day operation of the academy, in particular organising the teaching staff, facilities and students.

Arrangements for setting pay and remuneration of key management personnel

The academy's pay policy is linked to its appraisal policy. Key management personnel are remunerated in line with the national pay scales for the role they fill. Those in a teaching role are remunerated in line with the Teachers Pay and Conditions pay scales, whilst those in a non-teaching role are remunerated in line with the NJC pay scales. Each individual will be subject to an appraisal by their line manager. The Head Teacher undergoes an annual appraisal by at least one trustee along with an external advisor. These appraisals are discussed by the Finance, Policy and Personnel Committee prior to any incremental pay award being agreed.

Related parties and other connected charities and organisations

In March 2023 the Academy opened a charity which is linked to the 'Futures café that was opened on October 30th 2023. There are currently 6 Trustees on the committee. The café will be able to give valuable work experience opportunities to Maplefields students and all profit will go into the Alumni fund which will help support students in their next step after Maplefields.

The Academy leads Maplefields Training and Development which provides training to other schools in safeguarding and team teach.

The Academy is funded by North Northants to lead the SEMH outreach and support schools by developing their skills and knowledge of how to support students with SEMH.

Objectives and activities

Objects and aims

The principal object and activity of the charitable company is the operation of the Maplefields Academy to provide education for pupils of different abilities between the ages of 5 and 19 with an Education, Health and Care Plan (EHC Plan) and where severe Social Emotional and Mental Health difficulties (SEMH) is the primary need.

Objectives, strategies and activities

The main objectives of the academy during the year ended 31 August 2023 are summarised below:

- to ensure that every child enjoys the same high-quality education in terms of resourcing, tuition and care;
- to raise the standard of educational achievement of all pupils;
- to improve the effectiveness of the Academy by keeping the curriculum and organisational structure under continual review;
- to provide value for money for the funds expended;
- to comply with all appropriate statutory and curriculum requirements;
- to maintain close links with industry and commerce; and
- to conduct the Academy's business in accordance with the highest standards of integrity, probity and openness.

The academy's main strategy is to strive to motivate pupils who have so far found school a challenge by providing a safe, calm, and caring learning environment which is stimulating through the richness of displays and the caring, nurturing approach and encouragement given to each pupil by staff. We work to foster a sense of belonging and to provide the opportunity for all pupils to develop a sense of self-worth, confidence and control over their lives. To this end the activities provided include:

- tuition and learning opportunities for all students to attain appropriate academic qualifications;
- training opportunities for all staff, and especially teaching staff;
- secondments and placing of students with industrial and commercial partners;
- a programme of sporting activities for all students;
- an advisory service and a guidance programme to help students obtain employment or move on to higher education.

Public benefit

The Academy Trust promotes education for the benefit of the local community of Corby and offers recreational facilities to a variety of local community groups outside of School hours for the benefit of the general public. Community based projects are also undertaken throughout the year which further enhances the public benefit.

The Academy Trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers or duties.

Strategic report

Achievements and performance

Qualifications

Our students at Maplefields had another successful year. Notable highlights include GCSE grade 4's in English Language and Math's, as well as two grade 5's in GCSE Science. BTEC music also had two successful Level 2 Qualifications as well as Level 2's Sports Leadership. Pupils achieved Level 1 and Level 2 qualifications in Functional Skills English, Math's and ICT.

Target Setting

All Students at Maplefields are set individual targets based on their starting points at the beginning of the academic year once baselined. 80% of pupils met or exceeded their individual targets in English. 82% met or exceeded their targets in Math's and 81% met or exceed their targets in Science.

Professional Judgments

We use professional judgements at Maplefields to assess the overall holistic steps of progress made throughout the academic year taking all factors in to account. In the professional judgements of the staff that teach our pupils 82% of pupils in English made expected or better than expected progress, 81% in Math's and 80% in Science.

Teaching standards

Teaching standards continue to be good or outstanding on the whole. Last year we supported four ECT's (20%), 2 of which were Year 2 ECT's and therefore successfully completed the Early Careers Teacher framework to become fully qualified. The other two ECT's are on track to also be successful. This year 45% of our teaching staff were judged to be working at Good and 35% performing at Outstanding.



Behaviour and Suspension Analysis 2022/23

Since the previous OFSTED inspection, the school decreased the amount of behaviour incidents and suspensions over time taking into consideration our growth in PAN from 104 to 114. During the period of Covid and post Covid the number of incidents took an unusual dip and reduced significantly. Since the return to 'normal' it was expected that the number of incidents would increase to the 'norm.' This is due to the adverse experiences and challenges our students and families had over this time. Our challenges continue with the cost-of-living crisis, a national recruitment crisis and the need of places for specialist SEMH provision in North of the County. Even with these barriers that the school is presented with the school has managed to keep in line with the number of behaviour incidents since before Covid.

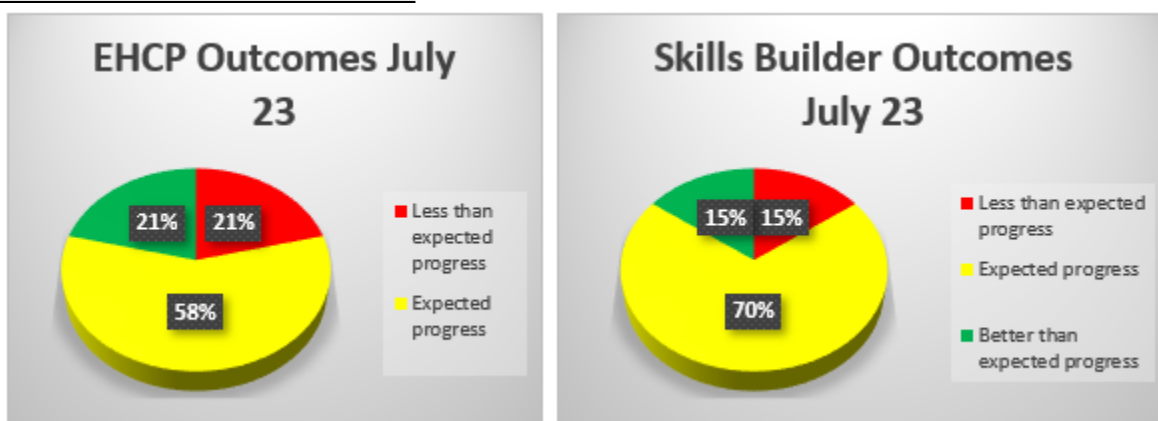
Attendance

Our average percentage attendance over the past academic year was 80.76%, which is a 2% increase on the previous year. With six PA's taken out the percentage rises 84.28%, which is a 1% increase over the previous year. When we break down the attendance data we can compare against both the national average for special schools and against other special schools in our locality. Over 50% of the weeks we matched or were higher than the national average and we consistently achieved higher attendance percentages over similar schools in our locality. Attendance procedures are constantly being reviewed to further refine and sharpen our practice.

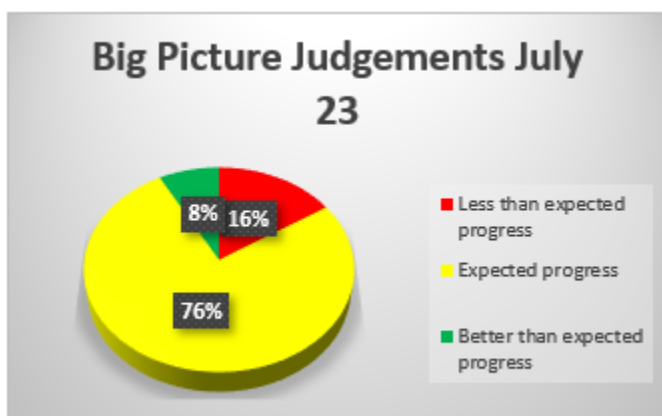
Skills Builder, EHCP outcomes and the BIG Picture

79% of our students at Maplefields were able to make expected or better than expected progress towards their EHC targets during this academic year. Progress towards Skills Builder (our skills-based curriculum) was also measured; with students making 85% progress towards their Skills Builder outcomes. When factoring in the EHCP outcomes, Skills Builder data, Target Setting and Professional Judgements; 84% made expected or better than expected progress at Maplefields.

When we factor in our EHCP and Skills Builder data alongside our analysis of Target Setting and Professional Judgement assessment we collate an overall BIG PICTURE judgement that represents both the academic progress made but also the Social and Emotional progress that our pupils have made over the course of the year. Overall Performance in Core Subjects

Core academic progress is taken by calculating the averages of Target Setting and Professional Judgements across Mathematics, English and Science and then an overall Core Judgement is taken.

Key priorities for the academic year 2023-24

1. Attendance – Continue robust monitoring process and use latest research to increase rates of attendance.
2. Reading – To embed and upskill new staff with reading policies, procedures and practices. Continue to refine process of the three Reading Ambassadors.
3. Vulnerable groups – Implement individualised strategies to reduce the gap between Looked after Children and the rest of the school cohort.
4. Curriculum – Continue to deepen the infrastructure behind each curriculum subject through the implementation of knowledge organisers.

Going concern

The financial uncertainties for Maplefields Academy are;

- Top up funding not being received from the Local Authority on time
- Teacher and Support Staff pay increases
- Cost of living crisis
- Rising Gas and Electric costs
- Cost of a new boiler in the near future
- Supply Costs

The management accounts allow the school to rigorously monitor the finances. If at any point the finances become a matter of concern, the school will open an additional class in primary and transition the 2023/24 students in earlier.

As at 31 August 2022, the academy had net current assets of £279,000 (2022: £452,000) and a bank balance of £208,000 (2022: £574,000). The academy had an operating deficit in the year of £155,000 (2022: £59,000 surplus), excluding depreciation and LGPS accounting adjustments.

The directors have set a balanced budget for the year ended 31 August 2024.

After making appropriate enquiries, the board of trustees has a reasonable expectation that the academy trust has adequate resources to continue in operational existence for the foreseeable future. For this reason the board of trustees continues to adopt the going concern basis in preparing the accounts. Further details regarding the adoption of the going concern basis can be found in the statement of accounting policies.

Financial review

A decrease in staffing levels raises concerns for safeguarding measures to be in place effectively. This will impact on staff wellbeing and cause higher levels of staff absence. As a result there will be higher levels of behaviour incidents which will have a negative impact on the progress of the students and therefore the effectiveness of the school.

Most of the academy's income is obtained from the Education and Skills Funding Agency (ESFA)/Department of Education (DfE) and North Northants County Council (NNCC) in the form of recurrent grants, the use of which is restricted to particular purposes. The grants received from the ESFA/DfE and NNCC during the year ended 31 August 2023 and the associated expenditure are shown as restricted funds in the Statement of Financial Activities.

The academy also receives grants for fixed assets from the ESFA/DfE. In accordance with the Charities Statement of Recommended Practice, 'Accounting and Reporting Charities' (SORP 2016), such grants are shown in the Statement of Financial Activities as restricted income in the fixed asset fund. The restricted fixed asset fund balance is reduced by annual depreciation charges over the expected useful life of the assets concerned.

During the year ended 31 August 2023 total revenue expenditure, excluding depreciation and LGPS pension accounting adjustments, was £3,793,000 (2022: £3,231,000) and total income and endowments from the DfE and other sources were £3,638,000 (2022: £3,281,000). Also during the year the trustees agreed to expend £49,000 of reserves on the purchase of new fixed assets.

At 31 August 2023 the net book value of tangible fixed assets was £8,834,000 (2022: £9,017,000) and movements in tangible fixed assets are shown in note to the financial statements. The assets were used exclusively for providing education and the associated support services to the pupils of the Academy.

Financial and risk management objectives and policies

The academy's risk management procedures are outlined above. The trustees believe that its risk management procedures mitigate as far as reasonably possible the principal risks and uncertainties facing the Academy Trust.

Cash flow is now monitored regularly by the Academy Trust and budgets presented to the Governing body consider cash flow and liquidity in detail.

Financial position

The academy held fund balances at 31 August 2023 of £9,113,000 of which £9,029,000 represents restricted funds.

Restricted funds include £8,853,000 in restricted fixed asset funds which will be offset by future depreciation of fixed assets.

Reserves policy

The impact of low levels of staffing and ensuring that the school has the ability to remain open safely may result in using the reserves to increase staffing levels and ensure the safety of staff and students.

To support the emerging mental health needs of the students and staff after a significant lockdown would raise costs of the use of specialist staffing such as the therapists.

The trustees review the reserve levels of the academy annually. This review encompasses the nature of income and expenditure streams, the need to match income with commitments and the nature of reserves. The Trustees have determined that the approximate level of free reserves should be equivalent of the payroll costs for two months, approximately £410,000.

The Academy's current level of free reserves (total funds less the amount held in restricted pension and fixed asset funds) is £260,000 (2022: £452,000).

Included within restricted funds at 31 August 2023 is the Local Government Pension Scheme deficit of £Nil (2022: £318,000). The pension deficit is viewed as a long term debt and annual contributions are adjusted as necessary to mitigate the risk and reduce the deficit.

Investment policy

The trust's investment policy is to invest surplus cash reserves with High Street banks with a high credit rating where the capital invested is guaranteed.

Principal risks and uncertainties

The trustees have assessed the major risks to which the academy is exposed, in particular those relating to the specific teaching, provision of facilities and other operational areas of the academy, and its finances. The trustees have implemented a number of systems to assess risks that the school faces, especially in the operational areas (e.g. in relation to teaching, health and safety, bullying and school trips) and in relation to the control of finance (Teaching & Learning Committee, Safeguarding Committee and Finance, Policy & Personnel Committee). They have introduced systems, including operational procedures (e.g. vetting of new staff and visitors, supervision of school grounds) and internal financial controls in order to minimise risk. Where significant financial risk still remains they have ensured they have adequate insurance cover. The Risk Register is a standing item on the Trustees agenda where any forthcoming risks are identified and a plan put in place to further minimise the risk.

Financial and risk management objectives and policies

Through the academy's risk management procedures, it has considered its principal risks and uncertainties and planned mitigating action wherever possible. The principal risks and uncertainties identified by the trustees are:

- Change in government funding regime – the academy receives much of its income from Government agencies;
- Reduction in student numbers either through competition or a damaged reputation/falling standards – the academy prides itself on the OFSTED grading from its 2023 inspection as a School which rated it as Outstanding, and recognises the importance of maintaining these standards.
- Reduction of staffing levels due to the recruitment crisis in Education which could lead to student staff ratios being a safeguarding concern. This leads to greater agency costs to support with the Academy being fully staffed.
- The significant increase in gas and electricity prices which has an ongoing impact on the budget.

Financial and risk management objectives and policies

Key controls that the academy has in place to mitigate these risks include:

- Attendance at government funding agency conferences and participation in focus groups to keep up to date with and influence as far as possible academy funding methodology;
- Appropriate organisational structure with several tiers of review;
- Internal quality assurance reviews and self-assessments
- To sustain the levels staffing by effective succession planning and a recruitment strategy.

Fundraising

Maplefields Academy engages in limited fundraising initiatives. It raises funds through rental of the school facilities (Sport Hall, football pitch etc.) and runs a small Christmas Fayre to sell goods made by pupils.

Plans for future periods

The academy will continue striving to improve the levels of performance of its students at all levels and will continue its efforts to ensure its students get jobs or a place in higher education once they leave. The academy will also increase its recruitment when necessary, accepting transfers from other schools and colleges where possible.

We are currently using a greening company to ensure the roof is being maintained correctly. This is being monitored and we are seeing encouraging signs of growth and recovery. This should help prevent any further damage on the roof going forward.

Auditor

In so far as the trustees are aware:

- there is no relevant audit information of which the charitable company's auditor is unaware; and
- the trustees have taken all steps that they ought to have taken to make themselves aware of any relevant audit information and to establish that the auditor is aware of that information.

A resolution proposing that Azets Audit Services be reappointed as auditor of the charitable company will be put to the members.

Scope of responsibility

As trustees, we acknowledge we have overall responsibility for ensuring that Maplefields Academy has an effective and appropriate system of control, financial and otherwise. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

The board of trustees has delegated the day-to-day responsibility to the Head Teacher, as accounting officer, for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the funding agreement between Maplefields Academy and the Secretary of State for Education. The accounting officer is also responsible for reporting to the board of trustees any material weaknesses or breakdowns in internal control.

Governance

The information on governance included here supplements that described in the Trustees' Report and in the Statement of Trustees' Responsibilities. The board of trustees has formally met 5 times during the year. Attendance during the year at meetings of the board of trustees was as follows:

As noted above the board met 5 times during the year and in addition to this the finance committee met 5 times. These meetings, together with other committee meetings and regular involvement of the Chair of Governors in day to day academy business (as required) provided effective oversight of funds.

Conflicts of interest

The Academy maintains an up-to-date and complete register of interests, which is shared on the school website and in the Trustees minutes. The Finance manual is in place, updated annually and is adhered to. All staff follow these processes and practices and this is monitored by the Finance Manager and the Accounting Officer.

Governance reviews

The Academy completes an annual skills audit which identifies any gaps in knowledge and skills. The most recent OFSTED visit (June 2023) identified the school to continue to be outstanding.

Finance, Policy and Personnel Committee

The finance, policy and personnel committee is a sub-committee of the main board of trustees. This committee also has the function of the audit committee within its remit as Maplefields Academy falls below the threshold for requiring a dedicated audit committee. Its purpose is to:

- consider the academy's indicative funding and assess the implications for the academy, making recommendations and/or raising concerns to the governing body;
- to consider and recommend acceptance/non-acceptance of the academy's budget, at the start of each financial year;
- to contribute to the formulation of the academy's development plan through consideration of financial priorities and the aims and objectives of the academy';
- annual review of staff pay scales and pay policy for teaching and non-teaching staff (within STRB criteria)
- performance review for Head Teacher;
- consider and implement any changes to the composition of the committee.

The Finance, Policy and Personnel Committee met 5 times during the period.

Review of value for money

As accounting officer, the Head Teacher has responsibility for ensuring that the academy trust delivers good value in the use of public resources. The accounting officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The accounting officer considers how the trust's use of its resources has provided good value for money during each academic year, and reports to the board of trustees where value for money can be improved, including the use of benchmarking data where available.

There is a surplus to carried forward as at 31 August 2023 of £260,000. This has been achieved by:-

- A robust system of financial management whereby management accounts are prepared regularly on a monthly basis and all variances to budget are analysed and explained. These are reviewed on a monthly basis by senior management and the trustees. Where necessary immediate corrective action is taken.
- Maintaining a regular review of the value for money achieved by the school. This includes reviewing all employment and commercial contracts.
- Regularly reviewing our staffing structure, ensuring it meets the school's needs and is cost-effective.
- The academy explores every opportunity to generate income. Income is also generated through grant applications and bids.

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an on-going process designed to identify and prioritise the risks to the achievement of academy trust policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in Maplefields Academy for the period 1 September 2022 to 31 August 2023 and up to the date of approval of the annual report and accounts.

Capacity to handle risk

The board of trustees has reviewed the key risks to which the academy trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The board of trustees is of the view that there is a formal ongoing process for identifying, evaluating and managing the academy trust's significant risks that has been in place for the period 1 September 2022 to 31 August 2023 and up to the date of approval of the annual report and accounts. This process is regularly reviewed by the board of trustees.

The risk and control framework

The academy trust's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the board of trustees;
- regular reviews by the finance, policy and personnel committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes;
- setting targets to measure financial and other performance;
- clearly defined purchasing (asset purchase or capital investment) guidelines;
- identification and management of risks.

The board of trustees has considered the need for a specific internal audit function and has decided not to appoint an internal auditor. However the trustees have appointed Friars Academy to perform additional checks.

The internal auditor's role includes giving advice on financial matters and performing a range of checks on the academy trust's financial systems. In particular the checks carried out in the current period included:

- testing of payroll systems
- testing of purchase systems
- testing of control account/ bank reconciliations
- review of various governance and associated business matters.

On a bi-annual basis, the internal auditor reports to the board of trustees (through the finance, policy and personnel committee/audit committee) on the operation of the systems of control and on the discharge of the financial responsibilities of the board of trustees.

Review of effectiveness

As accounting officer the Head Teacher has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

- the work of the reviewer;
- the work of the external auditor;
- the work of the executive managers within the academy trust who have responsibility for the development and maintenance of the internal control framework.

The accounting officer has been advised of the implications of the result of their review of the system of internal control by the finance, policy and personnel committee and a plan to address weaknesses and ensure continuous improvement of the system is in place.

1 Accounting policies

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgements and key sources of estimation uncertainty, is set out below.

1.1 Basis of preparation

The accounts of the academy trust, which is a public benefit entity under FRS 102, have been prepared under the historical cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2022 to 2023 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

Maplefields Academy meets the definition of a public benefit entity under FRS 102 and is a private charitable company, limited by guarantee and registered in England and Wales. The address of its principal place of business is given on page 1 and the nature of its operations are set out in the trustees' report.

The financial statements are prepared in Sterling, being the functional currency of the charitable company. Monetary amounts presented in these financial statements have been rounded to the nearest £'000.

1.2 Going concern

The trustees assess whether the use of going concern is appropriate, ie whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the charitable company to continue as a going concern. The trustees have made this assessment in respect of a period of at least one year from the date of authorisation for issue of the accounts and have concluded that the academy trust has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the academy trust's ability to continue as a going concern. Thus they continue to adopt the going concern basis of accounting in preparing the accounts.

The Trustees have taken consideration of the effects of COVID-19 in making their assessment.

1.3 Income

All incoming resources are recognised when the academy trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

Grants

Grants are included in the statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the statement of financial activities in the period for which it is receivable, and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grants are reflected in the balance sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

Donations

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

Other income

Other income, including the hire of facilities, is recognised in the period it is receivable and to the extent the academy trust has provided the goods or services.

Donated goods, facilities and services

Goods donated for resale are included at fair value, being the expected proceeds from sale less the expected costs of sale. If it is practical to assess the fair value at receipt, it is recognised in stock and 'Income from other trading activities'. Upon sale, the value of the stock is charged against 'Income from other trading activities' and the proceeds are recognised as 'Income from other trading activities'. Where it is impractical to fair value the items due to the volume of low value items they are not recognised in the accounts until they are sold. This income is recognised within 'Income from other trading activities'.

Donated fixed assets

Donated fixed assets are measured at fair value unless it is impractical to measure this reliably, in which case the cost of the item to the donor is used. The gain is recognised as income from donations and a corresponding amount is included in the appropriate fixed asset category and depreciated over the useful economic life in accordance with the academy trust's accounting policies.

1.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement, and the amount of the obligation can be measured reliably.

Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges are allocated on the portion of the asset's use.

All resources expended are inclusive of irrecoverable VAT.

Expenditure on raising funds

This includes all expenditure incurred by the academy trust to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

Charitable activities

These are costs incurred on the academy trust's educational operations, including support costs and costs relating to the governance of the academy trust apportioned to charitable activities.

Governance costs

These include the costs attributable to the academy trust's compliance with constitutional and statutory requirements, including audit, strategic management, trustees' meetings and reimbursed expenses.

1.5 Tangible fixed assets and depreciation

Assets costing £1,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the balance sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding that require the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the statement of financial activities and carried forward in the balance sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the statement of financial activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

Depreciation is provided on all tangible fixed assets other than freehold land, at rates calculated to write off the cost of each asset on a straight-line basis over its expected useful life, as follows:

Land and buildings	0.8% or 2% of cost
Leasehold Improvements	10% of cost
Computer equipment	25% of cost
Fixtures, fittings & equipment	20% of cost
Motor vehicles	20% of cost

Assets in the course of construction are included at cost. Depreciation on these assets is not charged until they are brought into use and reclassified to freehold or leasehold land and buildings.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the statement of financial activities.

1.6 Liabilities

Liabilities are recognised when there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the academy trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods of services it must provide.

1.7 Leased assets

Rentals under operating leases are charged on a straight-line basis over the lease term.

1.8 Financial instruments

The academy trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the academy trust and their measurement basis are as follows.

Financial assets

Trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at face value.

Financial liabilities

Trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost. Taxation and social security are not included in the financial instruments disclosure definition.

Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument.

1.9 Taxation

The academy trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the academy trust is potentially exempt from taxation in respect of income or capital gains received within categories covered by chapter 3 part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

1.10 Pensions benefits

Retirement benefits to employees of the academy trust are provided by the Teachers' Pension Scheme ('TPS') and the Local Government Pension Scheme ('LGPS'). These are defined benefit schemes and the assets are held separately from those of the academy trust.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the academy trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a projected unit method. The TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions are recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the academy trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high-quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to net income or expenditure are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the statement of financial activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses. Actuarial gains and losses are recognised immediately in other recognised gains and losses.

1.11 Fund accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the academy trust at the discretion of the trustees.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

2 Critical accounting estimates and areas of judgement

Accounting estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions

The academy trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 19, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2023. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

The fair value of the pension plan assets at 31 August 2023 is in excess of the present value of the defined benefit obligation at that date giving rise to a surplus of £332,000.

The surplus is recognised in the financial statements only to the extent that the Academy Trust can recover that surplus, either through a reduction in future contributions or through a refund to the Academy Trust. The Academy Trust is not able to determine that future contributions will be reduced and it is not possible to receive a refund, as the specific conditions for this have not been met. Therefore, an asset ceiling is in place such that the surplus of £332,000 is not recognised as an asset at 31 August 2023 as the Academy Trust is not able to determine that future contributions will be reduced or that a refund of the surplus will be available in the foreseeable future

The specific purposes for which the funds are to be applied are as follows:

Restricted General Funds represent General Annual Grant (GAG), which must be used for the normal recurring costs of the academy trust, together with other restricted general funds.

Under the funding agreement with the Secretary of State, the academy trust was not subject to a limit on the amount of GAG that it could carry forward at 31 August 2023.

Restricted Fixed Asset Funds represent resources which have been applied to specific capital purposes imposed by the funder together with cash resources still to be expended by the academy trust. During the year, a transfer of £38,150 was made from GAG funds to restricted fixed asset funds in order to fund the acquisition of various tangible fixed assets.

19 Pension and similar obligations

The academy trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Hymans Robertson LLP. Both are multi-employer defined benefit schemes.

The pension costs are assessed in accordance with the advice of independent qualified actuaries. The latest actuarial valuation of the TPS related to the period ended 31 March 2016, and that of the LGPS related to the period ended 31 March 2019.

There were no outstanding or prepaid contributions at either the beginning or the end of the financial year.

Teachers' Pension Scheme

Introduction

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for teachers in academies. All teachers have the option to opt out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary. These contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

Valuation of the Teachers' Pension Scheme

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019.

The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% employer administration charge)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million, and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI. The assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2023.

The employer's pension costs paid to the TPS in the period amounted to £267,802 (2022: £206,078).

A copy of the valuation report and supporting documentation is on the Teachers' Pensions website.

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The academy trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The academy trust has set out above the information available on the scheme.

Local Government Pension Scheme

The LGPS is a funded defined benefit pension scheme, with the assets held in separate trustee-administered funds. The total contributions are as noted below. The agreed contribution rates for future years are 20.6% for employers and 5.5 to 6.5% for employees.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.

The employees are paid within the normal pay scale for their roles and receive no special treatment as a result of their relationship to trustees.
